Benefits of Modernization

We are excited because...

Expected advantages of the new datums for your organization, its products, or services

- Combining of horizontal and vertical datums in one (1) system
- Expansion of low distortion projection (LDP) systems
- Increased accuracy and consistency within vertical datums
- New tools to streamline coordinate transformations
- Elimination of virtually all grid-to-ground conversions
- Closer integration with tidal datum information
- Additional uniformity for surveying practitioners

Challenges of Modernization

We are concerned because...

Expected challenges of the new datums for your organization, its products, or services

- Lack of metadata within historical information to adapt to the new datum
- Updating of existing surveying equipment to include new datum
- Enticing equipment and software manufacturers to implement
- Users with lack of understanding of a time-dependent datum
- Surveyors making time to learn about new datum.

Opportunities Provided by Modernization

Potential business opportunities are:

- Increased collaboration between private entities and public agencies
